Old Business:

- Peshtigo Area Rummage sale sponsors needed. We have sponsors of BPM, Subway and Natural Casing for total of \$350. We are exploring if 50 new signs can be made to provide to participants. Currently only 9 people are signed up, but historically most of the participants sign up in last week or so.
